6. POLICE MATTERS

The following matters were reported to Sgt. Further to the issue raised regarding the dangers at Pilsley Road Bridge, in discussion, it was AGREED that the County Surveyor be asked to comment on the construction of a footway tunnel for pedestrians. Clerk. A tree near the Brook was reported to be hollow and of some danger. AGREED Clerk. the County Council be informed. Complaints were made regarding horses riding on footpaths in the village. AGREED a letter be sent to the proprietor of the Riding School requesting Clerk. that horse riders should be warned this is an offence. 79/13. GENERAL BUSINESS a. Dr. Hunt agreed to have some dialogue with the Cricket Club regarding the Dr. Hunt former footpath across the Cricket Field. Following discussion, it was AGREED the Clerk arrange a Meeting with the Welfare Trustees to discuss the anomaly of Car Parking at the Village Hall/Welfare. Clerk. Queried as to the Village Pond suggested at Church Lane, Cllr.Mrs.Hudston replied that certain enquiries had been made, there was more to be made but unfortunateley the Vicar was away for some time which would cause delay. The Clerk refuted suggestions that the Elections had been poorly advertised and depicted the number of notices that he himself had posted irrespective of those posted by the District Council. AGREED that a letter be sent to Cllr. Swain wishing him a speedy recovery. Clerk. Also that a similar letter be sent to the School Caretaker, Mrs. Clarke, asking her to convey good wishes to her husband who was in Hospital and had undergone major surgery.

RADIO INTERFERENCE.(79/8 refers)

Cllr. Gough reported that the Post Office Engineers had now rectified this matter.

Whilst some small interference was still apparent caused by electric cables, the nuisance had been reduced to an acceptable level.

A letter from County level informed that no further progress could be made until and easement being negotiated with Mr. Barret was completed. Cllr. Harris stated that flooding had again be recently experienced and residents again making strong complaint at the apparent lack of action. The Chairman stated that the Parish Council and in particular the Clerk, was continually pressing this issue, but regrettably, if the landowner caused delay by agreeing an easement over his land, the scheme could not become operative. He understood from Cllr. Parr, that a little progress had been effected recently and we had to await confirmation.

Cllr. Mrs. Roper reported that temporary repairs had been effected to the gas leaks near the site and eventually new pipes would be installed. The Chairman reported that further opencasting had been approved at the Straw Lane site but it was pleasing to report that the Pilsly Road application had been refused. Cllr. Mrs. Bacon queried if the Action Group could have copy letters that related to the Dioxin Tipping by Coalite some years ago. The Clerk stated that he would search his files but it was probable that these had been destroyed as it was impossible to file everything indefinitely.

Cllr. Harris and Mrs. Roper supported the Clerk and stated they also remembered the instance of the closure.

AGREED the Clerk ring the Water Board. 79/19. IMPROVED STREET LIGHTING Members discussed a Plan displayed that had been sent by the County Council and also an accompanying letter suggesting priorities. Following a lengthy deliberation, Cllr. Harris suggested that it was inoppurtune to enumerate specific improvements until a site meeting had been held in the hours of darkness and this was AGREED. The matter was then deferred. 79/20. FINANCE The Clerk reported that the Precept of £1959 was now paid into the Bank. He would discuss with the Chairman the transfer of assets after assessing the Minancial position. There were no accounts for payment. 79/21. GENERAL BUSINESS a. Report was made of the masonary hanging loose on the Welfare outbuildings and it was again suggested that another attempt be made to convert these buildings into a Bus Shelter. The Chairman held out little hope for this suggestion since the County had less finance now than they had then. Cllr. Mrs. Hudston suggested that we contact the C.I.S.W.O'and ask them to dedicate the buildings to the Parish Council and efforts could be made to raise finance to restore the buildings. This was AGREED. (Cler It was AGREED to report to the Police, complaints regarding motor cyclist nuisances throughout the village and also youths motor cycleing withour crash helmets on Evershill Lane. Replying to suggestions of another notice board on the Welfare Footpath, Cllr. Harris stated this was a waste of money since we knew what would happen to it. It was also reported that a person repairing his car at the rear of 152 Main Road, then used the right of way to back of these premises as a trial course, thereby causing (Clerk nuisance. AGREED to be included in the complaints to the Police. Grit nuisance was complained of on the footpath from "itwell Vills to the bottom of the hill at Stretton on the B6014. AGREED this be reported to the Highway Authority. (Cler Cllr. Mrs. Bacon requested copy of the correspondence relating to the tipping of Dioxin by Coalite some years ago. The Clerk stated that this may well have been destroyed along with other papers since he could not file everything for ever. Signed-

- b. TOXIC WASTE. (79/15c refers) A letter from the Dept. of Environment Minister informed that little purpose would be achieved in meeting a deputation. He did suggest, however, that the County Council should be the Authority with whom to take up issue. Following discussion, it was AGREED that the Clerk seek a meeting with the appropriate Committee of the County Council. (Clerk)
- c. GRANT AID. (RECLAMATION SCHEME) 79/15d refers) The Clerk detailed a further site meeting with Mr. Cracknell, the County Engineer having phoned he could not attend. There was still no Play Area set out, but Mr. Cracknell pointed out land presumed to have been dedicated by Vic Hallam Homes to the District Council, which would be ideal for the project. He would enquire and then liase with County, following which he would prepare scheme. Relative to open ditches, a letter had been sent to Mr. Cowley. Mr. Hibbertson had also phoned the Clerk seeking a site Meeting on 26th.July, to which he would bring Mr. Carter the former Engineer, in the hope that the Parish Council complaints could be cleared up. The Clerk suggested that we should likewise invite Mr. Cracknell to give his expertise on the issue in general. Following discussion it was AGREED the Clerk arrange a site Meeting on 30th.July, at 2.30.p.m. and invite Mr. Cracknell. (Clerk)

- d. BUS SERVICES. (79/15e refers) The Bus Petition had been accepted and Mr. Orford had written in reply, evidently missing the main object of the Petition, The Clerk had replied and explained the issue in detail.
- e. FOOTPATH No.7.(79/15g refers) A further letter from Mr. Billington was read along with a copy letter sent to the District Council by D.Totty's Solicitors. The Clerk stated there was little more that could be reported other than the Bridge disrepair complaint had been reported and no reply received.
- g. GRIT NUISANCE. (79/21 refers) No reply to the complaint made to Highway Dept.

The Chairman detailed to Sgt. Monk, the nuisances by Notor Cycles on the occasion of the Quiz Competition in the Village Hall. The Clerk called out the Police, but by the time they arrived, the offenders had moved off. Sgt. Monk stated that this type of nuisance was being experinced in many places outside Morton and the Police were doing everything possible to eliminate the nuisance. The offenders were careful to ensure that they did not digress from the Law both mechanically and otherwise, which made the task of the Police more difficult. They were constantly endeavouring to educate these young people, with some slight success. Sgt. Monk also gave further enlightenment regarding obstruction by motor vehicles and promised to look into speeding complaints and also the indiscriminate tipping of rubbish.
