MINUTES of a Meeting held in Morton School, 15th. April 1980, at 7.00 p.m.

- 80/1. MINUTES of the Meeting held on 18th. March 1980 were approved after amendments, viz. addition to Minute 79/66 - 'that this Council will not withdraw objection to the proposed DIVERSION of Footpath 241, and alteration to Minute 79/75 - the word 'objecting' to replace 'querying' be inserted.
- 80/2. MATTERS ARISING FROM THOSE MINUTES
- a. EVERSHILL LANE FLOODING(79/70a refers) Copy letter of notification by County to Mr. Barrett informing him of enforcement action was read and welcomed. Cllr. Harris in reporting of current work being effected wished to place on record both his and the residents thanks for the support given to alleviate this problem. In particular, he thanked the Clerk who had evn made personal efforts at times to resolve the issue. The Chairman and Clerk suitably replied and hoped the problem was solved.
- TOXIC WASTE(79/70b refers) Letters from the M. P. informed that his efforts to b. obtain a Private Members Bill had failed. County also replied that . request to disclese the location of the Dioxin contaminated waste. Tibshelf Parish Council had requested copies of evidence that this tipping showed no contamination and through Chairman consultation, the Clerk had refuted the statement claimed and informed Tibson they could site only, what information we had. Dr. Hunt stated that he had consulted Dr. May regarding the breakdown of Dioxin and gained valueable knowledge. Cllr. Swain stated that there was far too much conjecture going about on this issue and the Parish Council should resolve that they were not satisfied with the disposal of both the Toxic and Dioxin Waste and that any future quotes on this issue were personal views only and not those of the Parish Council. Cllr. Mrs. Bacon stated that numerous breaches of the Licence had been reported and there was seemingly little action taken. The motion of Cilr. Swain was unanimously adopted and it was AGREED to write County regarding Licence breaches and also regarding the Drift Mine direction of approach towards the Dioxin site. Cllr. Parr was asl asked to enquire as to the results of the post mortems carried out on animals reputably deceased as a result of contamination poisoning. Copy letters to be sent to Clirs. Rowley and Wright at County level.
- . BUS STRVICE REVISION(79/72g refers) Further letter and Time Tables were read and lengthily discussed, particularly in respect of Hospital visitors. it was AGREED that any complaints made should be relayed to Cllr. Parr who was also asked to make known the Parish Councils viewpoints at County level. Relative to the broken Bus Stop sign, the Clerk stated County had this matter in hand.
- d. ... LITTER BINS(79/70e refers)- AGREED a letter of thanks be sent to the District Council for their services and ask if the Bin at the Village Hall could be replaced.
-), 5. BUTCHERS SERVICE(79/75a refers) A reply stated that lack of skilled personell had caused withdrawal of this service. Members agreed to enquire as to alternate means.
- . OVERFLOWING SEWER(79/75b refers) County informed that similar happenings were remote and that seepage problems were being investigated.
- . COACH PARKING & DIESAL TANK(79/75d refers) The Clerk reported on his enquiry at District Council. An Enforcement Order was being considered on this issue.
- NEW STREET HOUSE, No. 9(79/75c refers) this matter had been relayed to Clir. J. Rotter who had not replied to date.

480/487. Removal of unburnt refuse at old Morton Tip for C.D.Robinson. No objective principal but request landscaping afterwards and guarantee of no more tip.

Also to query County re interference with Red Lane as a footpath.

480/487. Lay out of Land for Industrial Estate roads and sewers between Station Road and Stomebrro Lane for Severn rent Water Board. Object on grounds that Stonebroom Estate not fully allotted as yet and Morton not Scheduled for Industry.

80/5. POLICE MATTERS

Complaints were made of Airgun and Pistol shooting on the Reclamation Site and troop and shrubs thereat also being vandalised. Motor cycles and scooters still persisted on Evershill Lane and the Recreation ground and a copy letter of complaint was rassed to the Constable to read and take note of. Complaint was also made of persons urinating in fields adjacent to Stretton Road.

80/6. HIGHWAY MATTERS

- a. Complaint was made of pot-holes almost everywhere in the Village. The Clerk noted specific cases which would be relayed to the County Surveyor.
- b. The Footbridge on Footpath No.7. was reported as dangerous. To be reported to Count.
- c. Discussion ensued on the dangers associated with the Welfare out-buildins and it was Agreed to write the Trustees informing them of liason with them regarding enquiring for Grant Aid to restore these buildings.
- d. It was reported that Footpath No. 4. was not negotiable and the Bridge thereon was vandalised. Agreed to inform County.

80/7. GREEN BELT MEETING

Cllr. Mrs. Hudston reported on the recent Meeting held and felt that some success was now becoming evident. A wedge area was in process of being formed and she would report further after the next Meeting.

The Chairman thanked Mrs. Hudston for her attendance and interest in this issue.

80/8. FINANCE

The following accounts were presented and Cheques signed for payment odf same:

Association Membership.. 26.79 following discussion and vote in respect of again re-joining. Voting resulted in 6 for and 2 against.
Cllr. Towndrow reported on the negotiation for new tables for the Village Hall and the Cheque for same was Agreed - £322.28. The Clerk to transport same from Chesterfield.

80/9. GENERAL BUSINESS

Complaint was made of obnoxious smells emanating from the factory site off Main Road. Agreed the District Council be requested to investigate.

In reply to questions regarding the sale of land by C.I.S.WO., the Clerk stated he had heard nothing further.

Mirutes of the ANNUAL ASSEMBLY MEETING held in Morton School, 27th. May 1980 at 7.0

- AS/1. MINUTES of the last Parish Assemblt Meeting held 24th.April,1979 were approved.
- AS/2. MATTERS ARISING FROM THOSE MINUTES None raised.

AS/3. POLICE MATTERS

Cllr. Harris reported the vandalism in respect of the huge coping stones pushed off the bridge on Higham Lane and stressed the dangers associated with nonsensical act. Cllr. Mrs. Hudston stated that she had comtacted the N.C.B. Opencast Dept. who had promised repairs would be effected. Cllr. Harris also reported the condition of the bridge over the cutting on Footpath No.7, this again being dangerous and in his opinion, the condition being helped along by some vandalism. Cllr. Mrs. Hudston reported the fire hazard in the old building at Church Lane and Cllr. Mrs. Bacon related incidents of Motor Cyclist nuisances at Evershill Lane. In a lengthy discussion on the merits and dis-merits of Police action, Both Officers present explained the lengths of investigation that the Police carried out, sometimes being obstructed by the Law in itself that placed certain restrictions upon them. However they always endeavoured to investigate any complaint made in full and it was wrong for the public to think they did nothing if at the end of the day as it were, there was headlines. Supporting the Police, the Clerk suggested that it had been muted in many quarters that the Law itself required some re-organisation to help the Police and Cllr. Swain agreed and stated that punishments were minimal and should be made to fit the crime. He also complained of lack of parental control and discipline in general that often caused much of the trouble and indeed, hindered the Police. The Chairman asked the Officers to appreciate that the Parish Council had welcomed the Police liason and thanked them for their work since its inception. The Officers suitably replied.

AS/4. CHAIRMAN'S REPORT

Tracing the events over the past year, Dr. Hunt detailed all the activities that had been pursued regarding the tipping of Toxic Waste and the dumping of Dioxin contami nated material. The Environentmental Health Committee set up had done splendid work, a joint Parish Councils Committee had be formed to which we had contributed both by delegates and finance and Morton Parish Council would still continue its objections at every level possible. He went on to explain that the state of the Highways and footpaths were continually reported despite County pleading lack of finance impeded remedial action. A milder Winter had made for less snow clearing complaints and at long last, the Evershill Lane flooding was he hoped successfully eliminated. We had rejoined the Association of Local Councils and had supported the Village Hall Management Committee by Grant and various other means. A new Playing Field for the children at the lower end of the Village was nearing completion and whilst the old Colliery Spoil Heap had been subjected to a reclamation scheme, the Parish Council had voiced its opinions that this was not as promised initially. He thanked the Police for their liason and all the Councillors, District, County and Parish, for all their support over a trying year. In particular he thanked the Clerk for his often tireless efforts on behalf of the Parish Council. A letter of thanks from Evershill lane residents was then read out.

In thanking the Chairman for a most comprehensive report, Cllr. Harris expressed his disappointment that there was no village residents present to hear what the Parish Gouncil endeavours were. He could only conclude they were satisfied. Cllr. Swain supported and stated he also wished to pay tribute to the Clerk for all the work he had carried out. The Report was adopted.

AS/5. FINANCIAL REPORT

The Chairman and Clerk explained the Parish Council finances which had been passed by the District Auditor and went on to explain the financial implications of the new Playing Field in respect of Urban Aid Grant.

The Report was unanimously adopted.

46. SERVERLE STATISTICS

Ollr. Rotter was requested to make some urgent enquiries regarding No.9. New W. since this residence was described as follow on the Street as a whole.

It was requested that the swings at the new Playing Field be amended to 2 Chair Seats and 2 radinary Seats. The Clerk promised to contact Mr. Cracknell. It was further reported that landscaping trees planted on the reclamation site had been pulled up and vandalised. County had already been informed.

A letter was read requesting the Parish Council to withdraw the objection to the Fastoral Measure since the Parochial Church Council had withdrawn its objection. Cllr. Mrs. Hudston, supported by the Chairman, took objection that the Parochial Church Council had refused Parish Council representation at the meeting when this matter was discussed. AGREED the Parish Council's objection remain in force.

Cllr. Towndrow reported on the lack of storage space at the Village Hall and this opened a lengthy discussion on the merits and dismerits of providing hirers with storage space for their equipment. No decision was taken on this matter other than Cllr. Towndrow was requested to obtain an estimate of the cost of a scheme he had suggested and report back in order that the matter could be further discussed.

The Clerk agreed to chase up the Community Industry regarding the outstanding items of repair for which they had been paid.

It was requested that the Clerk enquire as to the possibilities of a Litter Bin at the Corner Pin area.

Since nothing further had been heard regarding the offer of sale of land by CISWO, Cllr. Rotter undertook to query Mr. Billington on this issue.

- 3C/11. MINUTES of the Meeting held on 15th. April 1980 were approved and signed. The Clerk explained to Cllr. Mrs. Hudston the Minute presentation proceedure.
- 30/12. MATTERS ARISING FROM THOSE MINUTES
 - a. EVERSHILL LANE FLOODING(80/2a refers) Cllr. Harris reported that the recent rain storms had tried out the improvements and was pleased to say the trouble now seemed to have been cured at long last. Residents were pleased and he suggested that it was appropriate that we extend thanks to County for the work done. AGREED
 - b. TOXIC WASTE(80/2b refers) A further letter from Mr. Ashcroft still refused the site location of the Dioxin contaminated material dumped. The Clerk stated he had written to Cllr. Bookbinder seeking his comments and that Cllr. Parr had informed that his enquiries re deceased animals and other matters had been somewhat evasive.

 AGREED letters be sent to Shirland & Higham Parish enquiring if they were informed of the Dioxin location and also to the M. P. seeking his assistance on this issue.
 - c. BUS SERVICE REVISION(80/2c refers) The Clerk had obtained numerous copies of the time tables which Cllr. Hudston had circulated in the Village. Dr. Hunt made report that Mickley residents could not get to the Doctors Surgery and Cllr. Mrs. Bacon reported that people could not get home from work and also Hospital workers could not get home after 8.0.p.m. and the Health Authority could not help on this matter. AGREED that in forwarding the complaints to Mr. Orford, he also be asked to attend the next Parish Council Meeting and bring along a Bus Company representative.
 - d. LITTER BINS(80/2d refers) In reply to a telephoned enquiry, the Clerk had been told action would be taken as soon as possible. Cllr. Mrs. Shepperson stated that a new bin had been supplied at the Corner Pin.
 - e REMOVAL OF UNBURNT WASTE-PLANNING 480/48-(80/4 refers) The Chairman explained that was now a County matter and following receipt of a letter therefrom. he had instructed the Clerk to forward all the Parish Council's comments previously sent to the District Council, to County level and repeat the objection to any tipping. The Clerk stated all the information had been sent and read out the accompanying letter sent. Cllr. Harris stated that the letter certainly detailed the Parish Council's views and since he had visited the site, he failed to see what useable material there was to be had. It was AGREED that this issue should be carefully monitored as it developed.
- f. No. 9. NEW STREET(80/2h refers) The Clerk reported that Cllr. Rotter had informed him that following a mix up at District Council level, it was finally agreed that the house be sold and this decision was now awaited from the Housing Committee.
- g. P.STORAL MEASURE(80/3f refers) The Rev.Baltsleer had written confirming that Church representatives would attend the September Meeting to discuss this matter. The Chairman explained events leading up to this and stated that Mrs. Hudston and the Clerk had made every effort to accommodate the Church representatives otherwise.
- FROM HIGHWAY MATTERS(80/6 refers) There had been no reply to the complaints made re Pot-holes, but it was reported some work had been effected on this. There had also been no reply from the Welfare Trustees regarding repair to the out-buildings.
 - Regarding Footpath and Bridge complaints, Cllrs.Mrs.Hudston and Mr. Harris reported on a site Meeting held with a County Representative when all the complaints had been investigated. A letter from Mr.Underwood following this meeting informed that his Engineer had now been requested to make a report, following receipt of which, he would write again. The Chairman thanked Mrs. Hudston and Mr. Harris for their interest.
- i. SALE OF LAND(80/9 refers) Copies of correspondence relative to this had been sent to Cllr. Rotter who was enquiring further into this matter.

Details were also given regarding the continued vandalism of a footpath bridge handrail and matters relating to Footpath No.7. Relative to Main Street Parking, the Chairman suggested an approach be made to County level regarding intregated parking lay-byes as in many other villages and asked if the Police could give any support on this. The Sgt. stated he would consult the Police Road Safety Engineer for his opinion and in reply to questions on previous matters, he would enquire as to progress from the Officers who attended the last Meeting.

It was also reported that in the emptying of the refuse into the vehicle, spillage was left on the highway. It was reported that rubbish was being deposited at various places on Higham Lane and was thought to be associated with the refusal to remove certain refuse left out for collection. It was AGREED the Clerk report these matters and seek an interpretation of Household Refuse.
