84/182 Minutes of the meeting held on the 19th June 1984 were approved and signed.

84/183 Matters Arising:

84/164 House- Station Road. The single property would be dealt with on completion of the other houses.

84/176 Police. The Acting Chief Constable had written thanking members for their support.

Cllr. Beaver, a member of the Police Consultative Group, recommended that members attend a meeting of the Group which is proving most useful.

84/179 Vacancy. Mr. David Stanley Keeton of 23 stretton Road, Morton, was proposed to fill the casual vacancy and the clerk will formally write to Mr. Keeton to ascertain if he will accept the nomination.

84/180 Holiday Book Special. Members were disappointed that the 'bus will not stop at Bacchus Way and thought that the schedules were notified too late for amendment. An effort will be made to have this point re-instated next year.

84/184 Planning: Application 203 - bungalow at Morton Nurseries. The Planning Authority has refused consent.

Application 206 - change of use from four flats to two private residences, 119/121 Main Road, Morton. It was RESOLVED that no objection or comment be made.

Parr had failed to adequately represent Morton's interests at the last meeting. Plans produced at the meeting had been "amended" to exclude vital information over completion dates. Mrs. Bacon and Cllr. Beaver (also a member) felt strongly that those representing Morton should be seen to do so and it was RESOLVED that the clerk draw to Cllr. Parr's attention the Parish Council's concern. It would seem that officers of the County Council are less than helpful - they produced the maps - and it is important that all elected members act in concert to have to tip filled as soon as possible and in a manner satisfactory, not the officers, but to the local people.

Chesterfield Advertiser. There are no free newspapers circulating in the Morton area and the clerk will write to attempt to obtain such circulation.

Surgery. It was <u>RESOLVED</u> to request the District Council to reconsider the <u>location</u> of the proposed new surgery at Stonebroom.

<u>Culvert Scheme</u>. Cllr. Parr offered to investigate the possibility of culverting the stream to prevent destruction of private gardens.

Field by Dr. Hunt's property. The field had been treated for ragwort but the operators had not cleared the weed completely and this matter will be drawn to the attention of the County Council and/or the National Coal Board.

84/207 Minutes: The minutes of the meeting held on the 16th October 1984 were approved and signed.

84/208 Matters Arising:

84/201 Higham Lane. The County Council has now made an Order in respect of this highway. (7.5 tonnes).

84/201 Street light No. 36. This light was now reported to be working.

84/203 Venue of Meetings. The Village Hall Management Committee is prepared to allow the Council use of the hall for meetings. There being no proposal to move the meetings this offer will not be taken up.

84/204 Y.T.S. The clerk reported that the gutters of the village hall had been cleaned out but that damp is thought to be caused by other sources. The Y.T.S. plumber will investigate and submit a report and estimate.

84/205 Evershill Close. Cllr. Beaver reported that the matter of providing parking space is "on the list" of the District Council.

Police: Damage at hospital. A number of juveniles had been interviewed and reported. However it was clear that the hospital authorities had contributed to their own misfortune in not making the building more secure. Not all the offenders were from Morton village and some of the children involved were from parents who had complained to the police.

84/210 <u>Toxic Tip</u>: Cllr. Beaver reported that he was awaiting written confirmation that the tip would be completed by autumn 1985.

84/211 Precept: The limit of the Council's precept for the year 1985/6 is £1636.00. It was therefore RESCLVED to precept the District for this amount.

- 84/212 White Paper on 'buses: The District Council had recently joined forces with Chesterfield and Bolsover Councils in opposition to the Paper and had requested the clerk to distribute petitions and leaflets. clerk had returned the documents but had offered to distribute papers giving both sides of the Government's proposals. Cllr. Swain felt that the matter should have been placed before the Council and that the clerk should not have acted as he did. The clerk conceded that that may have been a better course but that in this highly political matter he had acted properly and that the District Council should not have made the request at all. general Members felt sympathy for both sides of the argument, that the clerk should be allowed some discretion but that the chairman needs to be kept fully informed of all matters which may be of interest to the Council.
- 84/213 Seat Evershill Close. A Mrs. Massey of 4 Evershill Close had written requesting the ramoval of the seat due to the nuisance caused by children playing on or near it. Cllr. Smith volunteered to interview residents to ascertain their views.
- 84/214 <u>Lights Back Lane.</u> The lights on Back Lane are out and the Church is to be contacted to try and establish ownership.
- 84/215 <u>Litter Bins</u>. It was <u>RESOLVED</u> to request the provision of a large litter bin near to the Village Mall and a replacement near to the Corner Pin Public House.

Prior to the commencement of the meeting Mr. J. R. Woodisse, Hon. Secretary of the Derbyshire Association of Local Councils spoke on the work of the Association and Members agreed to discuss the merits of joining the Association at a future Council meeting.

Mr. David Skinner attended the meeting at the invitation of the chairman and explained the problems of the "new" 'bus shelter which has caused some comment. Mr. Skinner agreed to assess the stress factors in the construction to ascertain if the front of the shelter could be removed. The result of his investigations will be conveyed to the clerk. The chairman thanked Mr. Skinner for attending the meeting at very short notice.

84/217 Minutes: The minutes of the meeting held on the 20th November 1984 were approved and signed.

84/218 Matters Arising: 84/204 Y.T.S. The plumber's report had not yet been received.

84/213 Seat - Evershall Close. Cllr. Smith had interviewed several residents and it was clear the main complaint was the nuisance caused by children and that the seat was valuable to the elderly. It was RESOLVED not to remove the seat. (Pc Barrass will check on the conduct of the children complained of and Cllr. Smith was thanked for his efforts).

Derbyshire Association of Local Councils.

Members and the clerk expressed some misgivings about membership and it was RESOLVED to defer consideration until the next meeting of the Council.

84/219 Police:

A friendly but noisy dog at the Live and Let Live Inn has frightened children and Pc Barrass will speak to the owner.

84/220 Planning:

NED 1284/906 Temporary siting of caravan at rear of 17 Main Rd. It was RESOLVED to raise no objection but to request a strict time limit on it's placement there being observed.

NED 884/643 Bungalow, Morton Murseries. Permission had been granted and Members expressed their concern that once again the views of local representatives had been ignored.

24/220 continued:

NED 984/701 The Model Aircraft Flying Club's application had been refused and it was RESOLVED to write to the planning authority expressing the Council's surprise at this decision. The site had appeared ideal and the refusal may end the life of the club - the planning authority will be requested to think again.

64/221 Finance:

Cheques of £11.20 for the rent of the school and £102.37 for materials for the 'bus shelter were signed. (VAT will be reclaimed by the clerk).

Precept. The Council had been thanked for restricting it's precept and an exchange of letters between the Derbyshire Association of Local Councils and the District Council was discussed. There is a clear difference of opinion between those bodies as to the legality of surcharging a Parish who "overspends" and until it is tested in a court neither opinion, in the view of the clerk, can be relied upon.

84/222 Other business: The D.A.L.C. has come down against the 'buses white paper and leaflets were given to Members.

Definitive Map. The County Council has confirmed that this will be updated and that this District is second in the order of priority.

Parishes Study. The chairman and Cllr. Towndrow had attended a meeting with the District Council and further comments will be asked for in due course.

Dangerous Pavements. The clerk was requested to report pavements (at end of Evershall Lane and between Back Lane and Marshall's shop) which become dangerous in wet or icey weather.

Land rear of Main Road, Morton. Following Mr. Radford's complaint the clerk had investigated further but the owner had not been positively identified. In any event Members agreed that there was little, if anything, that could be done by this Council.

At the conclusion of the meeting the Chairman wished all a happy christmas and a prosperous new year.
