# **Morton Parish Council**

At a meeting of the Parish Council held in the Old School Room on the 17th March 2004.

144/04 Members Present. Mrs M. Daykin, Mrs G.H. Dyer, Mrs E. Rowarth, Mrs M. Treweek, Mr B. Darby, Mr G. Antcliff and Mrs J. Easden.

Also in attendance were Mr P. Goodwin - Clerk and 4 members of the public.

145/04 Apologies. Mr M. Wilson and Mr I. Chamberlain.

146/04 <u>Councillors Absent.</u> None, as everyone was either in attendance at the meeting or had properly submitted their apologies.

7/04 Items from members of the public. The Bacchus Way street nameplate has been removed by the District Council but a replacement has not yet been erected.

**RESOLVED** to follow this matter up again with the District Council.

148/04 Police. PC Jaimi Pendrill reported that there had been no crime during February and just one theft of a motor vehicle during March so far. PC Pendrill has now been supplied with a pushbike to assist him in covering his beat area. Two matters were raised which were in relation to the gaps in the hedge on the boundary of the old pit yard and in this respect PC Pendrill will speak to Derek Kennedy. The other matter was the ongoing problem with off the road bikers on the football field and this was noted yet again for action when it is possible to do so.

Inspector Trevor Durham has responded to the Clerk's letter on behalf of the Parish Council regarding the ridiculously large geographical area that PC Pendrill currently has to cover without the regular availability of a suitable vehicle. A bid has been made to the Government for additional beat officer posts on the Clay Cross Section one of which would be used to supplement the beat covered by PC Pendrill.

149/04 <u>District Council.</u> Some local people have raised concerns about the caravan that is sited on the Evershill Close car park and this is currently being investigated by the District Council.

It was decided on a vote of 5 to 3 to leave the provision of hanging baskets the same as last summer i.e. two per post where the brackets are currently fitted.

**159/04** General Correspondence. Various items of correspondence were distributed amongst the councillors present.

Chesterfield Law Centre have written to ask if we would display some publicity material in respect of their latest recruitment drive which this time is aimed at recruiting and training volunteer Reception Workers for the Law Centre. In addition to valuable work experience the Law Centre offers accredited training with in excess of 60% of their volunteers progressing to paid work or further/higher education over the past 4 years.

Consultation is taking place both by the Office of the Deputy Prime Minister and the Standards Board in respect of the proposals to issue Regulations and guidance relating to the arrangements by which local authority monitoring officers may investigate allegations of misconduct by members referred to them by ethical standards officers. Comments have to be submitted by the 18<sup>th</sup> May 2004.

The County Council have written to confirm that an investigation has been made into widening Evershill Close but as there are a number of utility pipes that would require re-routing this makes any such scheme too expensive to be justifiable.

**RESOLVED** to note the correspondence as listed above and it was agreed that publicity information from Chesterfield Law Centre should be displayed within the local community.
