**RESOLVED** to note the correspondence as listed above and to delegate authority to the Chair to make any comments as appropriate on behalf of the Parish Council with regard to the Local Plan Review.

The District Council have written to confirm that the first Annual Meeting for Neighbourhood Partnerships will be held in the Council Chamber, Council House, Saltergate on Thursday 23<sup>rd</sup> September 2004; there will be two sessions held, the first at 3:00pm and the second at 6:00pm with the meeting closing at 8:15pm.

**RESOLVED** to note the above time and date of the meeting and to try and ensure that at least two councilors are in attendance.

The District Council have written to say that following the Dogs (Fouling of Land) Act 1996 the Order (effective from 10<sup>th</sup> July 1998) only applies to limited areas of the District, with Byelaws applying to some parks and other public open spaces. Amendment of the existing order to extend its application to the whole of the District would consolidate all enforcement powers under a single system that applies to the whole of the District to allow easy enforcement by officers dealing with owners who fail to remove their dog's faeces. As part of the process of updating and amending the Order the District Council would like to hear our comments on it along with any other views on how the problem of dog fouling can be tackled.

**RESOLVED** that the Clerk should complete the response sheet on the Parish Council's behalf and return it to the District Council by Friday 28<sup>th</sup> May 2004 stating that this Council is supportive of the initiative but that good publicity is needed before it is implemented.

### 19/05 Reports from Parish Council Representatives on other bodies.

**Village Hall** - Councillor Wilson will take the points arising from the new lease back to the Village Hall Management Committee in order that this matter can now be finalised.

**Church** - Councillor B. Darby was not in attendance at the meeting but Councillor Daykin read out a thank you letter in respect of the Parish Council's contribution towards the maintenance of the churchyard.



School - Nothing further to report at the moment.

Cricket Club - The cricket club have requested a grant of £100 towards this summers activities.

Older People's Welfare Committee - A request for a grant towards a replacement heater in the Old School Room has been received, as the total cost of the work will be approximately £1,000.

**RESOLVED** to note the verbal reports which were received and to authorise a grant of £100 for the cricket club and £500 towards a replacement heater in the Old School Room.
