2. Nomination papers must be delivered to the Returning Officer, Council House, Saltergate, Chesterfield, Derbyshire, S40 1LF on any day from the date of this notice during normal office hours but no later than NOON on Monday, 4th April 2011.
3. If any election is contested the poll will take place on Thursday, 5th May 2011.
4. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at Council House, Saltergate, Chesterfield, Derbyshire, S40 1LF by 5 pm on Thursday, 14th April 2011.
5. Applications to vote by proxy at this election must reach the Electoral Registration Officer at Council House, Saltergate, Chesterfield, Derbyshire, S40 1LF by 5 pm on Thursday, 21st April 2011.
6. Applications to vote by proxy at this election applied for on grounds of physical incapacity, where that physical incapacity occurred after 5 pm on Thursday, 21st April 2011, must reach the Electoral Registration Officer at Council House, Saltergate, Chesterfield, Derbyshire, S40 1LF by 5 pm on Thursday, 5th May 2011.
